Qualifications

Persons selected for Civil Grand Jury service must commit to serving for a period of one year,
July 1 through June 30. Civil Grand Jurors are expected to spend between 10 and 25 hours
per week on their duties. It is not uncommon for Civil Grand Jury members to serve four to five
days of a given week. The time commitment may fluctuate depending on the member's role on
the Civil Grand Jury and the time of year. It is important that all Civil Grand Jurors be in
attendance each session throughout the year of jury service, except for planned vacations or
emergencies. A full body of jurors is essential for productive discussion of issues and decision-
