HOW TO TURN IN FIREARMS AND AMMUNITION

You must turn in or sell your firearm(s) and ammunition within 24 hours of service of the order. Please read the following information carefully. If you choose to sell your firearm(s) and ammunition, the buyer must be a federally licensed gun dealer (location information on the back of this page). Effective January 1, 2024, the restrained party is also prohibited from purchasing, owning, or possessing body armor.

****You must act promptly! You have 24 hours to relinquish your firearms and 48 hours to file proof of compliance with the Court.** This deadline applies during weekends and holidays. Law enforcement agencies are available at all times. Additionally, you have the option to sell or store your firearm(s) with a licensed gun dealer.

Firearms include:

- Handguns and pistols
- Rifles and shotguns
- Black powder firearms and muzzle-loading firearms
- Assault weapons
- Any weapon that sends a projectile through a barrel and the weapon's frame or receiver

To turn in your firearm(s) and ammunition, follow the instructions below:

1. You should call the police station to make arrangements to turn-in your firearm(s) and/or ammunition, then:
2. Bring your firearm(s) and/or ammunition unloaded, in a locked box or separate storage to the police station (location information on the back of this page). Make sure to bring your ID and your court order and to follow the instructions provided when you telephoned.

You must also file proof of compliance with the Court within 48 hours. You may use the corresponding form CH/DV/EA/GV/SV/WV-800 for this purpose of the documents provided by the law enforcement agency or licensed dealer.

How to File the Receipt for Firearms and Firearm Parts Form CH/DV/EA/GV/SV/WV-800

You can file the Receipt for Firearms and Firearm Parts Form electronically (instructions available at <https://sf.courts.ca.gov/online-services/e-filing>) or in person by submitting a hard copy to the San Francisco Superior Court clerk's office.

To file using the Dropbox:

1. Make two copies of the completed form.
2. Retain one of the copies for your records.
3. Place the original, one copy, and a self-addressed stamped envelope in a larger envelope or large clip.
4. Place the items in the drop-box outside the respective clerk's office at 400 McAllister St, San Francisco, CA 94102.
5. The clerk will mail you a file stamped copy of your document.
6. You must retain your unstamped and subsequent stamped copy as your proof of relinquishment.

To file with a clerk:

1. Make a copy of the completed form.
2. Bring the original and the copy to the clerk's office on the first floor at 400 McAllister St, San Francisco, CA 94102.
3. The clerk will return a file stamped copy to you.
4. You must keep the stamped copy as your proof of relinquishment.

Important Safety Instructions

- Your firearm(s) must be unloaded.
- Place your firearm(s) in your locked trunk. If you do not have a trunk, lock your firearm in a container and place it in the back of your vehicle, out of reach.
- Do not put the gun in your glove compartment (CA Penal Code 12023.1(a)).
- Drive directly to the agency; do not drive to other locations.
- Park as instructed.
- Firearm(s) must remain locked and secured, as previously mentioned, until relinquished to law enforcement.
