Deadline for Application: August 31, 2023 (Applications received after this date will be considered for the next training)

Minimum Requirements (California Rule of Court 2.812)

- Admitted to the California Bar for at least 10 years before appointment
- Member in good standing with the State Bar with no pending disciplinary action
- Has not pled guilty or no contest to a felony, or has not been convicted of a felony that has not been reversed
- Has satisfied the education and training requirements
- Has satisfied other general conditions the court may establish
- Has satisfied any additional conditions the court may require for an attorney to be appointed as a temporary judge for a particular assignment or type of case

Education and Training Requirements (California Rule of Court 2.812(c))

- Mandatory training on bench conduct and demeanor (3-hour course)
- Mandatory training in ethics (3-hour Online Class)
- Substantive training
