 - Friday at 9:00 a.m. (matters involving unwed parties, without children)
 - Trials as set by the court.
- Family Law Discovery Requests for Order including, but not limited to, Motions to Compel and DVRO discovery requests (Fam. Code § 6309). Matters to be heard on the 1st and 3rd Fridays at 1:30 p.m. or as set by the court.
- Family Centered Case Resolution calendars, including Status Conferences to be heard Monday at 10:00 a.m. 18 Month Review Hearings will be heard on the 2nd and 4th Monday in the afternoon.
- 3-Year and 5-Year Dismissal calendars to be heard on the 2nd and 4th Monday in the afternoon.
- Readiness calendars will be heard Monday at 9:00 am by Judge Gold, however the case and Request for Order will remain assigned to 403 or 404 for hearings.
- Default/Uncontested Judgment Review and Prove-Up Hearings will be assigned to Judge Gold.
- Other matters as assigned by the Unified Family Court Supervising Judge
