**GENERAL ORDER RE: IMPLEMENTATION OF EMERGENCY RELIEF
AUTHORIZED PURSUANT TO GOVERNMENT CODE SECTION 68115 BY CHAIR
OF JUDICIAL COUNCIL**

On March 16, 2020, the Superior Court of California, County of San Francisco (“Court”) requested an emergency order. On March 16, 2020, the Honorable Tani G. Cantil-Sakauye, Chief Justice of California and Chair of the California Judicial Council issued an Order granting emergency powers. Pursuant to Government Code § 68115 and the Chief Justice’s Order, effective immediately, this Court **HEREBY FINDS AND ORDERS AS FOLLOWS:**

1. The Court hereby extends by not more than 21 days the duration of any temporary restraining order that would otherwise expire from March 16, 2020 to April 15, 2020 inclusive, because the emergency condition described within the March 16, 2020 Order of the Chief Justice prevented the court from conducting proceedings to determine whether a permanent order should be entered (Gov. Code § 68115(a)(7));

2. The Court hereby extends the time period provided in Penal Code § 825 within which a defendant charged with a felony offense must be taken before a magistrate from 48 hours to not more than 7 days, applicable only to cases in which the statutory deadline otherwise would expire from March 16, 2020 to April 15, 2020 inclusive, (Gov. Code § 68115(a)(8));

3. The Court hereby extends the time period provided in Penal Code § 859b for the holding of a preliminary examination from 10 court days to not more than 15 court days, applicable only to cases in which the statutory deadline otherwise would expire from March 16, 2020 to April 15, 2020 inclusive, (Gov. Code § 68115(a)(9));

4. The Court hereby extends the time period provided in Penal Code § 1382 for the holding of a criminal trial by not more than 30 days, applicable only to cases in which the statutory deadline otherwise would expire from March 16, 2020 to April 15, 2020 inclusive, (Gov. Code § 68115(a)(10));

5. The Court hereby extends the time period provided in Welfare and Institutions Code § 334 within which a hearing on a juvenile dependency petition must be held by not more than 15 days, applicable only to minors for whom the statutory deadline otherwise would expire

1 from March 16, 2020 to April 15, 2020 inclusive, (Gov. Code § 68115(a)(12)); and

2 6. The Court hereby extends the time period provided in Welfare and Institutions
3 Code § 657 within which a hearing on a wardship petition for a minor charged with a felony
4 offense must be held by not more than 15 days, applicable only to minors for whom the statutory
5 deadline otherwise would expire from March 16, 2020 to April 5, 2020 inclusive, (Gov. Code §
6 68115(a)(12)).

7 IT IS SO ORDERED.
