**PRESIDING JUDGE ANNE-CHRISTINE MASSULLO
ANNOUNCES NEW CRIMINAL CASE DASHBOARD ON
THE COURT'S WEBSITE**

Innovative Tool Makes San Francisco the first Court in the State to Publish Real-Time, Interactive Criminal Data Metrics on its Public Website

The Court is launching a criminal case dashboard on its website that updates daily and includes extensive data on felony and misdemeanor cases – the first such data tool to provide public accountability and measures to assess the Court’s case management performance, Presiding Judge Anne-Christine Massullo announced today.

The criminal dashboard, which can be viewed [here on the Court’s website](#), includes statistics and charts on filings, Motions to Revoke, criminal case clearance rates, active caseload, future scheduled trials, trials, trial outcomes, convictions and dismissals.

“This has been a priority of mine since I became Presiding Judge nearly two years ago,” Presiding Judge Massullo said. “The Court routinely receives data requests from the public and justice partners – and now that information will be readily available while reducing staff time to address frequent data requests. This

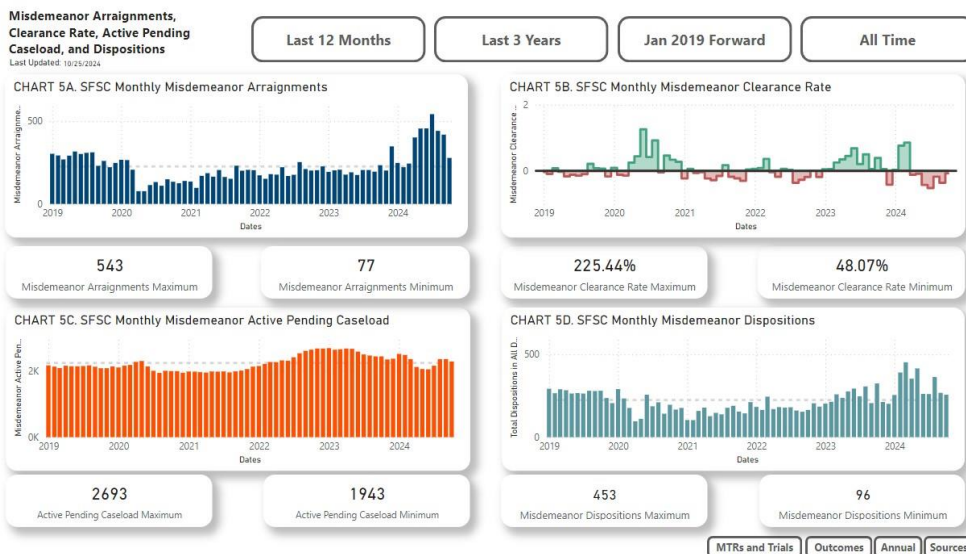

dashboard provides the public and our justice partners with valuable insights into the processing of criminal cases. By visualizing key metrics such as caseload, clearance rates, and trials in real-time, the Court is providing instant access to frequently requested data while fostering trust and engagement with the public we serve.”

Court Executive Officer Brandon E. Riley noted the Court is using its data to improve efficiency and to make the Court accountable and more accessible to the public.

“I want to acknowledge Presiding Judge Massullo and Assistant Presiding Judge Rochelle East for their vision and commitment to lead the Court toward continued innovation and achievement on a state and national level,” Riley said. “I commend the data team that designed this tool. This is a significant improvement in transparency, which is a high priority for us as we strive for increased community understanding of the Court and engagement with San Franciscans.”

The dashboard is the most recent addition to the Court's efforts to offer convenient and free access to court data. Earlier this year, the Court launched a Criminal Case information Portal, which includes a complete chronological calendar and register of action for criminal cases. The portal is easily accessible on the Court's [website](https://sf.courts.ca.gov) (sf.courts.ca.gov) at this link: <https://sf.courts.ca.gov/online-services/case-information>.

The criminal portal provides easy access to help the public search by case number, defendant name, and attorney name to track updates, case history, and status of a case.
